



Terms and Conditions

1. Entrants must be 18 or over 18 years of age and in attendance at Manchester City v Tottenham Hotspur match on 24th November 2013 (the “**Match**”)
2. In order to be eligible for entry, fans must successfully tweet via Twitter their image with the #FlyMeTo backdrop positioned around Etihad Stadium to @etihadairways using the hashtag #FlyMeTo before kickoff (pursuant to Clause 12 below). Each entrant with a Twitter account will gain one entry into the competition. Multiple entries from the same Twitter account will not be counted.
3. One winner will be chosen at random by a panel of judges at Etihad Airways during the first half of the Match, and they will be announced and/or displayed on the big screens at half time
4. Etihad will contact the winner via Twitter to arrange prize collection. If the winner does not respond to Etihad within 10 working days of the date of Etihad contacting them then another winner will be chosen once.
